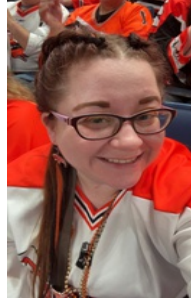

Organizational Excellence: 1) Club is in good standing with LCI, MD-20, and district dues paid, and 2) key officers participate in specified training events, and 3) improved club operations through the Club Quality Initiative to identify opportunities for improvement.

NYS & Bermuda Lions Foundation MD-20 Grant Program

The Foundation is a non-profit 501(c)(3) organization that assists in the support of charitable efforts of Lions clubs

throughout New York State and Bermuda. The Foundation provides its assistance through a grant process with an emphasis on sight, hearing, and humanitarian services.

Humanitarian Service Grants may be issued for permanent communal programs or institutes, which satisfy humanitarian needs in harmony with the objectives of Lionism.

Vocational Assistance Grants may be issued for programs meeting a broad range of educational and training programs, which provide a means for people to become self-supporting or to improve upon their economic and social well-being. Funds will not be granted directly to individuals for such purposes.

Operational Grants will provide supplemental funding for day-to-day operational needs of supported activities.

Emergency Grants may be approved by the President or the Grant Committee of the New York State and Bermuda Lions Foundation for immediate assistance following a natural disaster. Emergency grants are not to exceed \$2,500.

Grant proposals may originate from any sub-district District Governor or trustee of the requesting club's sub-district.

The proposal must certify the significance of the need addressed, the social value and operational feasibility of the proposed project and the validity and reasonableness of the grant request. The certification of the sub-district cabinet is required, demonstrated by submission of the minutes of the meeting at which the application was certified or a Cabinet Secretary letter confirming cabinet certification/endorsement. Grant proposals must be received 30 days prior to the next Foundation meeting.

Cullen Fund

Administered by ConnectLife low-income or under-insured individuals are referred to the Cullen Fund by Lions Club members, social workers, and physicians. It is preferred that

applications be approved before any medical procedure is performed.

Payments (up to \$1,000 for medical procedures per eye) made by the Fund are sent directly to the service provider. Financial support is given based on verification of an applicant's demonstrated need.

District 20-N Humanitarian Fund

The District 20-N Humanitarian Fund in honor of Lion Ray Wheeler is authorized to collect donations from and disburse funds to District 20-N Lions Clubs for defined humanitarian service projects located in District 20-N. All District 20-N Lions Clubs are requested to contribute to an annual Fall appeal. The Fund requests a per member donation of \$1.00, additional Club donations are also welcome and encouraged. Donated funds are restricted to use by the Fund. Each Lions Club may submit two matching grant requests per Lions year (either for their Lions Club or a collaborative project with other District 20-N Lions Clubs), with a total maximum request annual of \$500.

Lions Clubs providing defined humanitarian service in District 20-N in an area not served by a Lions Club or outside the District 20-N boundary may request a grant covering 80% of the project not to exceed \$250. Such grants are not counted against their two annual request total or the \$500 maximum annual request.

Completed applications and supporting documentation are sent to the Fund Chair who shares the submitted information to the Fund Committee (DG, VDG's, IPDG, CS, CT, [or CS/T], the Region and Zone Chairs in the area(s), the Lions Club(s) request is from, and the Fund Chair). Upon approval, the disbursement check is sent to the requesting Lions Club President.

The ASHAF helps those who cannot afford hearing assistance to receive testing and where indicated, a new digital hearing aid.

20-N Past District Governor's Assoc.

The 20-N Past District Governor's Association (**PDGA**) mission is to serve as an advisory group for the current District and Vice-District Governors.

PDGA members are also encouraged to identify and support qualified Lions to consider future leadership roles in District 20-N. One of the ways they accomplish this is by providing financial assistance to the District Governor, Vice-District Governor, District Governor Elect, Vice-District Governor Elect, and other District 20-N Lions who have made it known they are interested in potential District 20-N leadership roles by volunteering to attend a Lions sponsored program providing Lions training and leadership skills.

Currently the **PDGA** financially assists District 20-N Officers and other Lions by repaying documented unreimbursed expenses and in certain instances payment for expenses related to participating in leadership training provided by Multiple District 20 and other educational venues.

Current financial support includes:

- The current District Governor and partner-in-service are eligible for financial support for unreimbursed travel and incidental expenses to attend the Lions Clubs International convention.

The current District Governor is eligible for a partial reimbursement of expenses to attend a USA/Canada Lions Leadership Forum if he/she has not attended one in the past. (NOTE: District 20-N has a Restricted Fund administered by the District Governor to reimburse a Vice-District Governor for attendance at a USA/Canada Leadership Forum.)

- The current District Governor is eligible for partial reimbursement of expenses to visit a District 20-N Related Agency as published in either the previous or current year's District 20-N Directory

- The District Governor Elect combined with the VDGs Elects are eligible for a portion of their hospitality room supplies at MD-20 convention.

The current District Governor and 1st Vice-District Governor will be reimbursed a portion of unreimbursed expenses for attendance at MD-20 Council of Governors Meetings.

-PDGA will reimburse 75% of the cost of tuition for each Lion approved to attend the MD-20 Leadership Institute

Also, the **PDGA** annually recognizes one Lion from District 20-N who has demonstrated the qualities of a "Lion Leader". All Lions are invited to submit nominations using a standardized form. The **PDGA Leadership Award recipient** is honored at a breakfast meeting of the MD-20 PDG Association in conjunction with the MD-20 NYS & Bermuda Lions Annual Convention.
